- A recognized university Bachelor degree
- 36 calendar months experience leading projects gained over the last 8 year period
- 35 hours of project management education/training or an existing CAPM® Certification

— or —

- A high school diploma
- 60 calendar months leading projects gained over the least 8 year period
- 35 hours of project management education/training or CAPM® Certification

The STS PMP preparation course provides the 35 hours of education requirement.
